Mother and Childcare Project

While doing our work we found that due to the remote and segmented geographic locations, the health and hygiene facilities are very poor, many children died due to malnutrition. No clothes to wear, no healthy food, and every second child is malnourished or underweight. Early marriage, lack of awareness about health, poor health conditions cause severe anemia in them. Once a woman gets anemic in pregnancy period, she suffered with it for life time, which also effects on mental health also. Due to anemic conditions infant mortality is always high, and even if the child survives, it also born malnourished with low weight and weak health conditions. A poor prenatal nutrition contributes to health risks. We distribute multivitamin tablets to pregnant and lactating women who are at risk of malnutrition, results observed are very impactful. Providing supplemental nutrition in the form of a daily prenatal multivitamin is an excellent way to meet the expanded need. This includes 15 vitamins & minerals for meeting daily nutritional requirement of pregnant woman. Prenatal help support healthy pregnancies, prevent anemia, promote fetal growth, and ensure that babies are born at a healthy birth weight. Multivitamins are crucial to the health and survival of the growing baby and to the health and well-being of the mothers. We are focusing on this problem since 2015, more than 12000 pregnant and lactating women and 25000+ children benefitted through this project.





While giving helping hands to the underprivileged population residing in villages and to make them self-sufficient by giving them industry required skills so that they can take care of themselves, We have established 'Vivekanand Institute', a 18000Sq.ft training center at Pegalwadi, Trimbakeshwar & 5000Sq.ft training center in the heart of the city at Meher signal, Nashik.

Swami Vivekanand Beghar Niwara Sevashram (Shelter for Homeless people) –

Organization initiated a project for homeless people where we take care of 90+ homeless people who are mainly oldage, physically handicapped or mentally unstable. Alongwith food and other needs we are helping them with medical care also. Our main focus is to bring them into mainstream, by skilling them and to give them a employment.



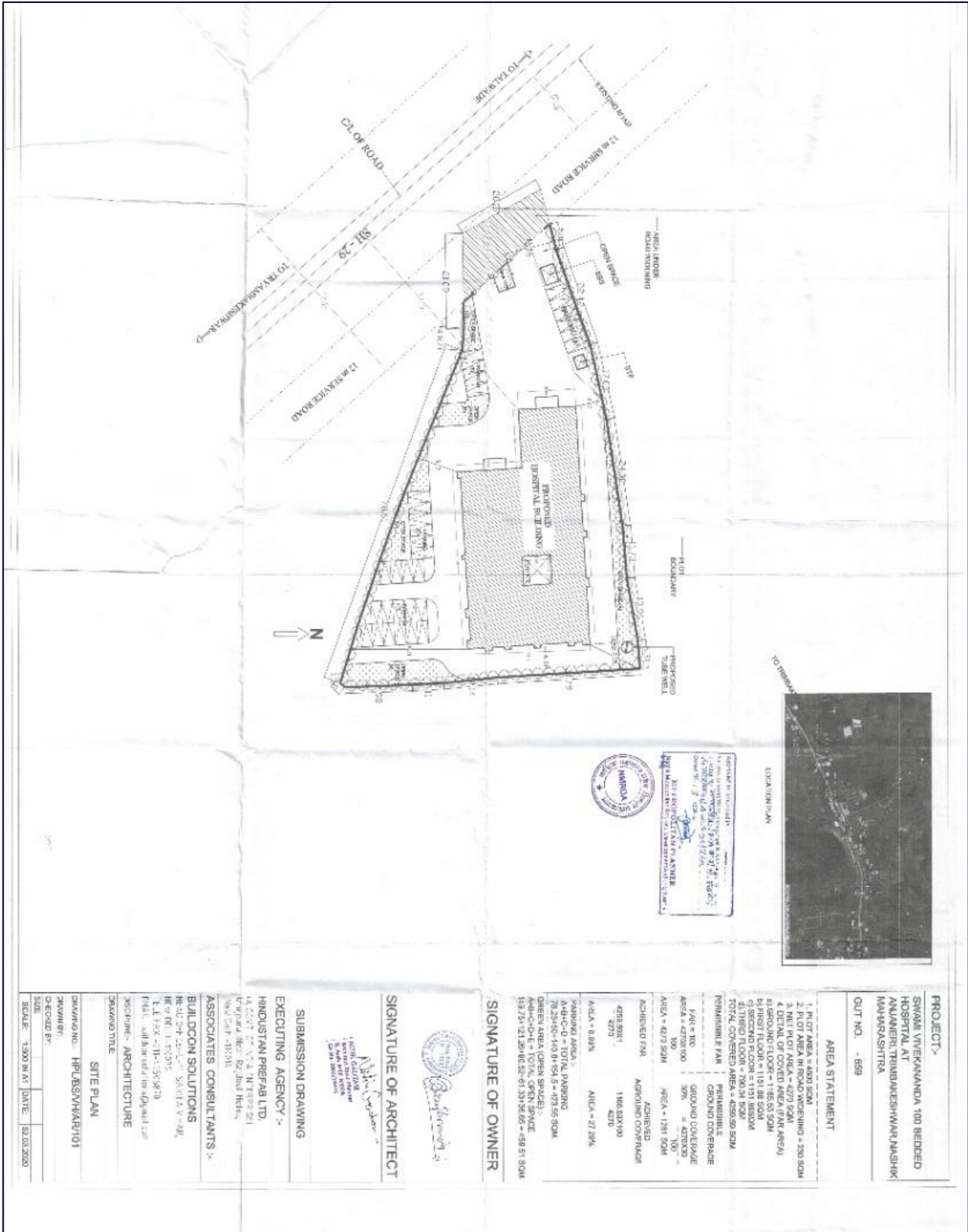

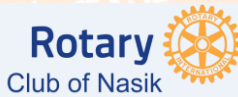
